RE: PERSONAL INJURY EXPERIENCE

1. I was admitted as an attorney in 2008 and as an advocate in 2011. I have been a member of the Pretoria bar since 2011.
2. From 2011, the bulk of my practice has been Road Accident Fund work, acting for both Plaintiff and Defendant.
3. I have been involved in medical negligence since 2019 in both public and private sector, acting in a broad range of matters on behalf of the plaintiff.
4. I am frequently instructed as a curatrix ad litem in personal injury and family law matters.

5. I have asked Auxcon who have acted as my bookkeepers since 2012 to furnish me with their available statistics. I am advised, that since 18 September 2012 to date, I have been involved in:
 - a. 749 RAF matters; and
 - b. 30 MEC (Health) matters.
